SCHOLARSHIP CONTEST RULES AND REGULATIONS

1. Contestant must be a Tinker Federal Credit Union member.
2. NO purchase necessary. VOID where prohibited.
3. ONE entry per contestant. Any entry must be the sole work of the contestant (high quality copies of the original work are acceptable).
4. Entries will not be returned.
5. Only official entry forms must be used.
6. Winners will be selected by independent judges, and winners will be notified by October 29, 2021.
7. A \$1,000 scholarship to the best entry in each of the following categories:
 - A. Ages 3 to 7 (as of January 1, 2021)
 - B. Ages 8 to 12 (as of January 1, 2021)
 - C. Ages 13 to 15 (as of January 1, 2021)
 - D. Ages 16 to 18 (as of January 1, 2021)
8. In addition to the four (4) \$1,000 scholarships, Tinker Federal Credit Union will award a \$500 scholarship to the Honorable Mention winner in each category.
9. Award winners will be required to sign a Liability/Publicity Release (where legal) to receive their respective award. Awards may be reported as taxable income.
10. Scholarship checks will be awarded to the winning contestants by management of TFCU Financial Advisors and Tinker Federal Credit Union.
11. Employees and children of employees of TFCU Financial Advisors, Tinker Federal Credit Union and Raymond James Financial Services, Inc. are NOT eligible for the contest.
12. No correspondence will be given regarding the competition itself, and the selections of judges are final.
13. All entries must be received or postmarked by Thursday, September 30, 2021.
